- b. <u>Website Survey Entry</u>: Visit the Downtown Point website (downtownstevenspoint.org) and complete the Holiday Window survey with all required contact information, including first and last name, email address, phone number and selecting the name of the participating business in which you are voting for. Data rates may apply if you are using your mobile phone to access the website survey.

Entry Limit: Limit of one (1) entry per person for the duration of the Sweepstakes Period, regardless of the method of entry. If more than one (1) entry is received from the same person, telephone number, and/or email address, only the last entry received may be considered valid. All entries become the property of Administrator and will not be acknowledged or returned.

- RANDOM DRAWING: On or about December 3, 2018, one (1) potential winner will be selected in a random drawing from among all eligible SMS Text Message Entries and Website Survey Entries received by the Administrator during the Sweepstakes Period.
